



## Acceptance of goods

### Acceptance of goods

Goods and movable property can only be accepted, without exception, against presentation of an official identity card.

Goods intended for the inmates will be accepted by the remand prison only if they will not endanger the peace, order and security of the prison. In principle, only underwear, clothes, shoes, safety razors, books, wrist watches, jewellery, reading spectacles and cash are accepted.

Goods that are too large or prohibited may be rejected or returned at the expense of the sender. However, if the goods are expensive or quickly perishable, the sender may be asked to collect the goods within a reasonable period of time of not more than 14 days. After the expiry of the period or if the sender cannot be found, the goods may be either utilised, destroyed or stored with other movable property.

Special regulations apply to the acceptance of goods on the three working days before and after Easter, Christmas and birthdays.

The inmates will be informed of any receipt of goods which are not handed over to them.

The prison management decides on exceptions.

No.	Permitted goods	Comments
1.	<b>Clothes, Shoes</b>	A number of pieces of clothes and shoes allowed in the cells is limited (space and order).
2.	<b>Money</b>	Handover at the gate against receipt.
3.	<b>Books</b>	Pornographic, sexist or violence-glorifying media are not permitted. Magazines will not be accepted.
4.	<b>Valuables:</b> <ul style="list-style-type: none"><li>▪ Neck/arm chains</li><li>▪ Watches</li><li>▪ Finger rings</li><li>▪ Earrings</li><li>▪ Glasses</li></ul>	Valuables that endanger safety are not permitted.  In the case of valuable items, the prison management decides on permission or rejection.
5.	<b>Electric shavers with integrated battery (incl. charging station)</b>	Beard & hair cutting devices as well as any battery-powered devices are not permitted.
6.	<b>Medicines / Medicines</b>	Accepted only by order of the prison medical officer

**Goods accepted on birthdays, at Christmas and Easter (gifts)**

Gifts for inmates are accepted only three working days before and after birthdays, Easter and Christmas. A maximum of 7 kg of goods can be dropped off per inmate. Larger quantities will be rejected.

Gifts can only be dropped off in combination with a reference to the inmate. They must be handed over to prison staff for inspection and forwarding.

All gifts must be in unopened original packaging.
